Bids will initially be evaluated in terms of: (1) Functionality, (2) Preferential Procurement Policy Regulations of 2017 using the 80:20 points system, where 80 points are allocated to price and 20 points are allocated to B-BBEE Level of Contribution,

The minimum qualifying score for functionality is 70 points out of 100 points. Only bidders that achieved the minimum qualifying score will be evaluated further, in terms of the Preference Point System and Administrative Compliance.
