PUBLIC TENDER ADJUDICATION

A notice for rescheduling of any meeting will be communicated in advance through the same platform as the initial communication.

All interested parties need to provide proof of identity at the entrance: Only SA National identity document and valid passport will be accepted.

Tenderers or members of the public who want to attend need to "please respond" - (RSVP) through the Supply Chain Management Unit at JOSHCO using the below contact details at least 48 hours before the meeting. The primary intention in this regard is solely to enable JOSHCO to make the necessary arrangements in respect of suitable capacity and venue coordination. No person or party or member of the public shall have any entitlement or right to speak at such Bid Adjudication Committee meeting, nor shall they have the right to address any member of the committee either before, during or after the meeting.
