- ✓ The tenderer must have minimum B-BBEE status level of contributor of **Level 1**
- ✓ In case of JV (Joint Venture)/ consortium, bidders to submit a consolidated B-BBEE certificate

Stage 2: Administrative Compliance.

Stage 3: Preferential Procurement Policy Regulations of 2017 using the 80:20 points system, where 80 points are allocated to price and 20 points are allocated to B-BBEE Level of Contribution

Stage 4: Award Criteria

- ✓ Preference for the award will be given to bidders who are at least **51% owned by black people; with special preference to black female ownership**
- ✓ Preference for the award will be given to Bidders who are situated within **Johannesburg.**
