Bids will be evaluated in four stages:

Stage 1: Pre-qualification criteria: -

- CIDB Grading 8GB/8CE or higher.
- Attendance of compulsory site briefing - Bidders must attend, complete and sign the compulsory attendance register.
- Proof of bid bought document

Stage 2: functionality: -- Only bidders who score 70 points out of 100 points on functionality will be evaluated in terms of administrative compliance

Stage 3: administrative compliance: – Bidders who fail to submit all required documentation for administrative compliance might be awarded on condition.

Note: If you meet the minimum requirement for this panel and you already in any of the JOSHCO existing panel, you will be required to make a choice to be in only one of the existing panels.
