### INVITATION FOR SUPPLIERS TO REGISTER ON THE JOSHCO SUPPLIER DATABASE

Johannesburg Social Housing Company (JOSHCO) hereby invites all prospective and current service providers to register for listing on the JOSHCO supplier database.

JOSHCO endorses BBBEE initiatives and encourages all interested SMMEs to apply and register on the JOSHCO database, preference will be afforded to Exempt Micro Enterprises or Qualifying Small Enterprises that are at least 51% owned by black people who are women, in line with Preferential Procurement Regulations, 2017.

With effect from 1 July 2017 and as part of the listing criteria for accrediting prospective service providers and, in line with Section 14(1)(b) of the Municipal Supply Chain Management Regulations, proof of registration in the National Treasury Central Database System is required as a mandatory requirement for listing.

The CSD assists in performing validation functions of key supplier information on behalf of Municipalities and Municipal Entities.

To be registered on the JOSHCO database, prospective and existing service providers are requested to submit the following documents:

- Central Supplier Database forms (as stated above)
- Completed supplier application form compulsory obtainable on the JOSHCO webpage: [http://www.joshco.co.za/?page\\_id=2768](http://www.joshco.co.za/?page_id=2768)
- Valid tax clearance certificate
- Company profile
- Original certified copies of ID documents of directors or members
- Certified copies of company registration documentation
- Original valid B-BBEE certificate or certified copies thereof, letter from the company Auditor, Accountant or Accounting officer
- Original Proof of banking details stamped by the bank
- Proof of any Professional Body Recognition and Professional Designation if applicable, such as SAICA, CIDB, ECSA, and so on.
